1. PLACE AND DATE

The Event is a 1 day Event and will be held on Saturday 11th May 2024 at the SHEPPARTON & DISTRICT CLUB track, Little Road Mooroopna.

2. ENTRIES

3. CLASSES

(Drivers will be graded into the following classes)

P Class. Standard vehicles (two wheel drive)

C Class. Modified vehicles (two wheel drive) up to and including 1600cc

D Class. Modified vehicles (two wheel drive) between 1601 and 2000cc

E Class. Modified vehicles (two wheel drive) 2001cc and over

L Class. Ladies

J Class. Juniors (Between 12 or 14 years as appropriate and under 18 years)

S Class. Specials & Buggies

W Class. Production 4WDs (No engine capacity limit)

Junior Competitors must be under the age of 18 years, on 1 January of the year of competition. Juniors may compete in any class of vehicle but will be ineligible for class points in class W or S vehicles. If a Junior enters a class S or W car they shall compete in the appropriate open class regardless of their age.

A junior competitor whom competes in an "open" class must continue to compete in an "open" class for the remainder of the year.

Ladies who drive a Class S or W vehicle must compete in the Class S or W for the rest of the year. - Refer the VCAS 2023 Standing Regulations for full details

4. STARTING ORDER

Competitors will start based numbers given during drivers briefing. Any competitor not able to start in their specified order, when requested to do so by the start official, may be deemed a non-starter. It is the Driver's responsibility to make sure they in order and have completed the required runs.

5. DRIVERS

- (a) The Event will be open to members of the SDCC and who are holders of a current Motorsport Australia Speed/Non Speed junior, Introductory licence or superior licence.
- (b) All Competitors are required to wear snug fitting clothes covering the body from neck to wrist to ankles and suitable footwear. Clothing should be of a **fire resistant nature**. All apparel, including helmets must comply with the requirements of Schedule D of the Motorsport Australia Manual.
- (c) INSTRUCTORS AND INEXPERIENCED DRIVERS

If the Club Chief believes an inexperienced Driver needs an Instructor in the car with him/her, he will arrange for an Instructor to be appointed and go with that Driver. This will continue until the Instructor is satisfied that the Driver is competent to go on his/her own. This Event will have Instructors in vehicles.

(d) PARENTAL CONSENT If any Competitor or Driver is under 18 years of age, the consent of his/her Parent or Guardian must appear on the Entry Form. The Parent/Guardian must stay at the track.

6. SCRUTINEERING

All vehicles must be scrutineered and passed for competition prior to participation. Motorsport Australia Licences, Competition Records and Motorsport Australia Log Books (if issued), and current Club Membership Cards must be produced at scrutiny and on request during the meeting.

All Drivers must be able to self-extract within a maximum of 15 seconds. Tests will be done during scrutineering in accordance with Motorsport Australia policy.

7. PASSENGERS

This Event will include a Motor Sport Passenger Ride Activity (MSPRA) which shall be run under and in accordance with the Motorsport Australia MSPRA Policy. Passengers must be 12 years of age.

8. COURSE

The event will be run over 1.6km (approx) of gravel/dirt defined by tyres, witches hats and bunting.

9. VEHICLE ELIGIBILITY

- (a) Vehicles must conform with the General Requirements for Cars and Drivers as per Schedule A and Group 4K of the Motorsport Australia Manual. All vehicles must be fitted with a suitable front and back towing hook.
- (b) All vehicles must be fitted with two separate fastening systems on any opening front panel in accordance with Schedule B.
- (c) Fire extinguishers to a standard listed in Schedule H of the Motorsport Australia Manual must be securely fitted to the vehicle. As per the Motorsport Australia Manual *Each AS1841 standard fire extinguisher shall be serviced every three years.*
- (d) Any vehicles competing in Class S must be fitted with rollover protection. Rollover protection is highly recommended in all other cases as per Schedule J of the Motorsport Australia Manual.
- (e) Fuel shall be with Schedule G Motorsport Australia Manual
- (e) Road tyres only. No rally tyres or square edged tyres. Clerk of Course will be the Judge of Fact.

10. RUNNING DETAIL

The number of runs will be determined by the Clerk of the Course, dependent on the condition of the track.

11. Pre-Grid

The breaking of traction in the pre-grid bitumen area **WILL** result in immediate disqualification and will result in expulsion from the remainder of the Event. The Clerk of the Course will be the judge of fact.

12. STARTING PROCEDURE

Competitors will line up in Pre-Grid in order and will be moved onto the starting pad as instructed. The starter will indicate to the Driver when to proceed onto the course via lights or signals.

Multiple Driver cars and working officials who may also be Competitor will have a separate staging lane to be able to slot into gueue guickly to keep to running order against single driver cars.

13. FINISH PROCEDURE

At the end of each run the driver is to immediately decelerate the vehicle and proceed to the pit area. At all times when moving within the pit area and leaving the track area, the maximum speed limit is to be 10kph.

14.REFUELING OF VEHICLES

This may only be carried out in the designated refuelling area located near the parking area. <u>NO REFUELING IS TO BE CARRIED OUT IN THE PITS OR PADDOCK.</u>

15. POSTPONEMENTS OR ABANDONMENT

The Organiser reserves the right to abandon, postpone or stop the Event in accordance with the NCR, or if insufficient entries are received. If the Event is cancelled or postponed for more than 24 hours, the entry fees shall be refunded in full.

16. SMOKING

Smoking (which includes e-cigarettes and "vaping") and any naked flame is prohibited within 3 metres of any refuelling/defueling operation.

17. INTEGRITY

Motorsport Australia's National Integrity Framework and any associated policy (including the Australian Anti-Doping Policy. Motorsport Australia's Illicit Drugs in Sport (Safety Testing) Policy, the Motorsport Australia Alcohol Policy), apply to any activity authorised by Motorsport Australia as published at www.motorsport.org.au.

Any Participant including the holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol, any drug or other banned substance. In addition to any penalty imposed by Motorsport Australia, a further penalty/s may be applied by Sport Integrity Australia.

Consumption of alcohol in any Reserved Area is prohibited until all Competition is concluded each day

18. NOISE

All competing cars must be fitted with a device that restricts the exhaust noise level to a maximum of 95dB (A) measured at a distance of 30 metres on a drive by test under full acceleration. Vehicles may be checked during competition. Any competitor's car that exceeds this limit will be warned. A second offence will result in expulsion from the remainder of the event.

19. PROTESTS

Protests must be lodged in accordance with the NCR and accompanied by the appropriate fee.

20. INTRODUCTORY LICENCES

These are available on the day at a cost of \$30. This licence enables a new driver to compete without obtaining a full licence. It is good for the whole event. ONLY ONE CAN BE USED ONCE. Introductory licence will not be included in the results.

21. CATERING

Catering will be open from 9:30am on Sunday till the afternoon.

22. NO SMOKING AREA (which includes e-cigarettes and "vaping")

The area around and between the Timing/Catering Container and the Toilet Block is a NO SMOKING AREA.
